The First Further Notes will rank pari passu with, and share the same security as the Initial Notes. The notes being in aNGN (New Global Notes) format will initially be issued as Temporary Global Notes and then not earlier than 40 calendar days after issue and after the noteholder has declared its tax status be replaced with the Permanent Global Notes. The First Further Notes will at first, for operational purposes, be issued under a new temporary ISIN, but will then be merged with the Initial Notes. Once consolidated with the Initial Notes, the First Further Notes will share the same ISIN as all other Notes in issuance.
