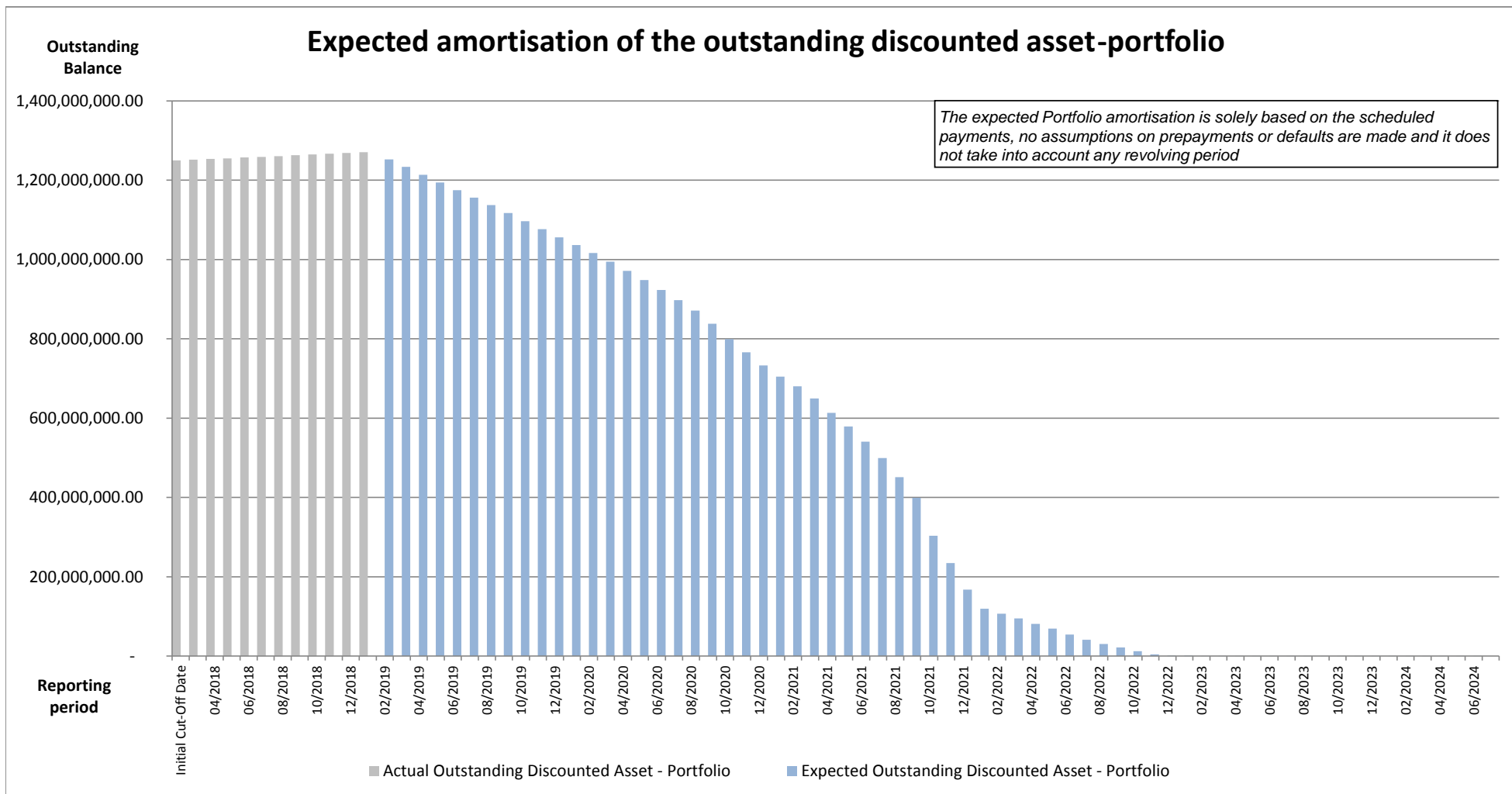
Amortisation profile II

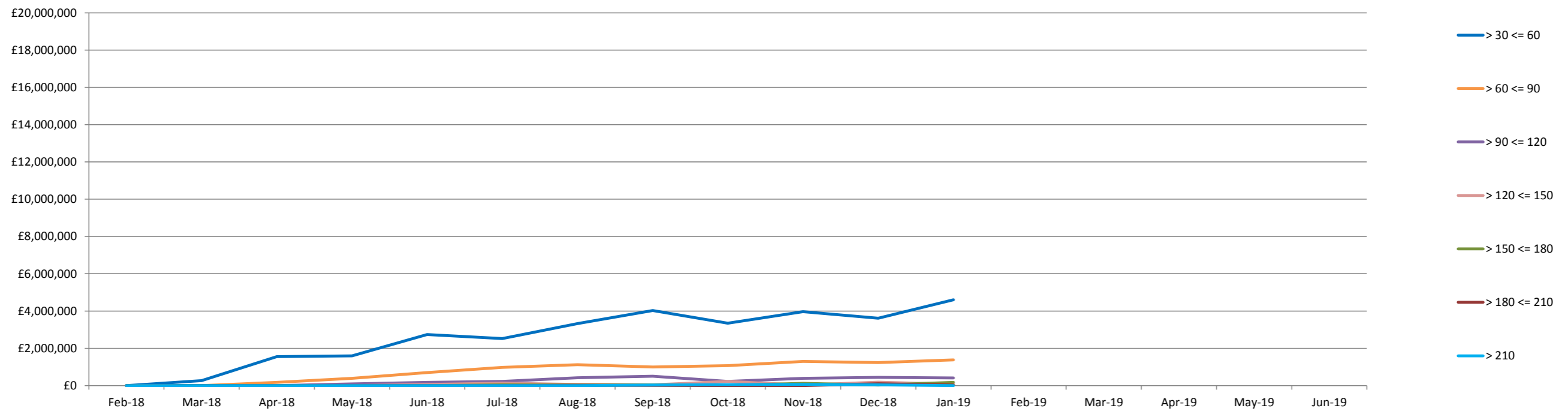

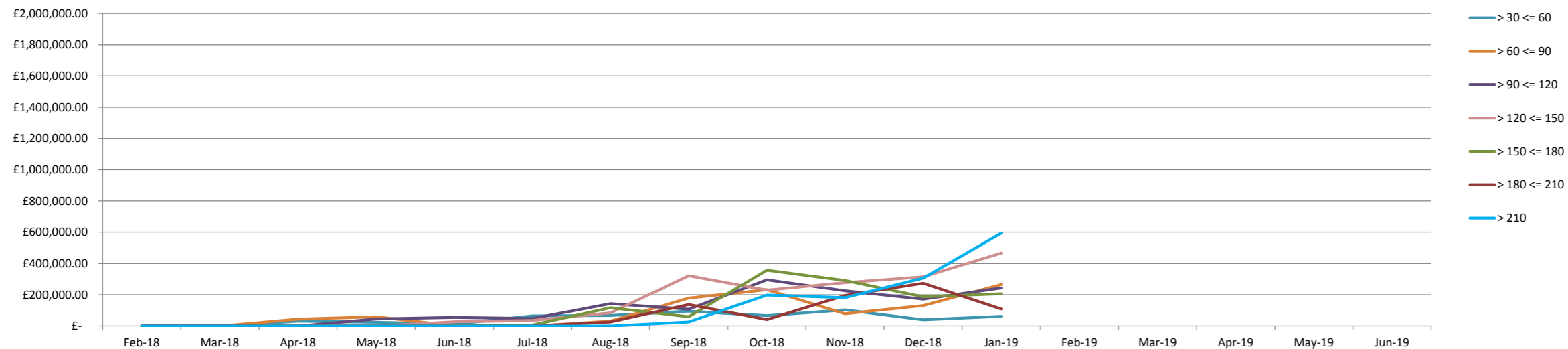

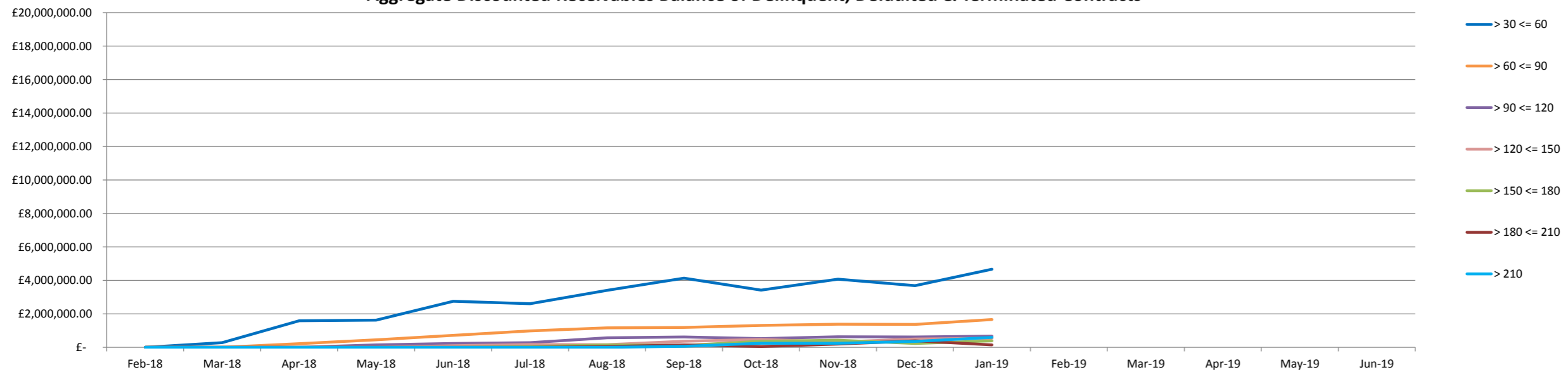
Aggregate Discounted Receivables Balance of Terminated & Defaulted Contracts



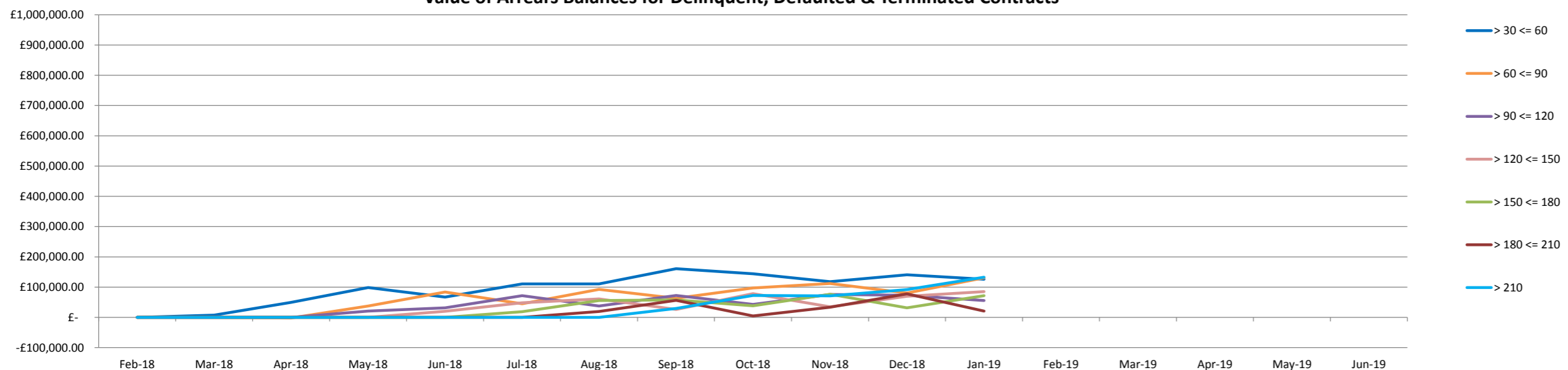
