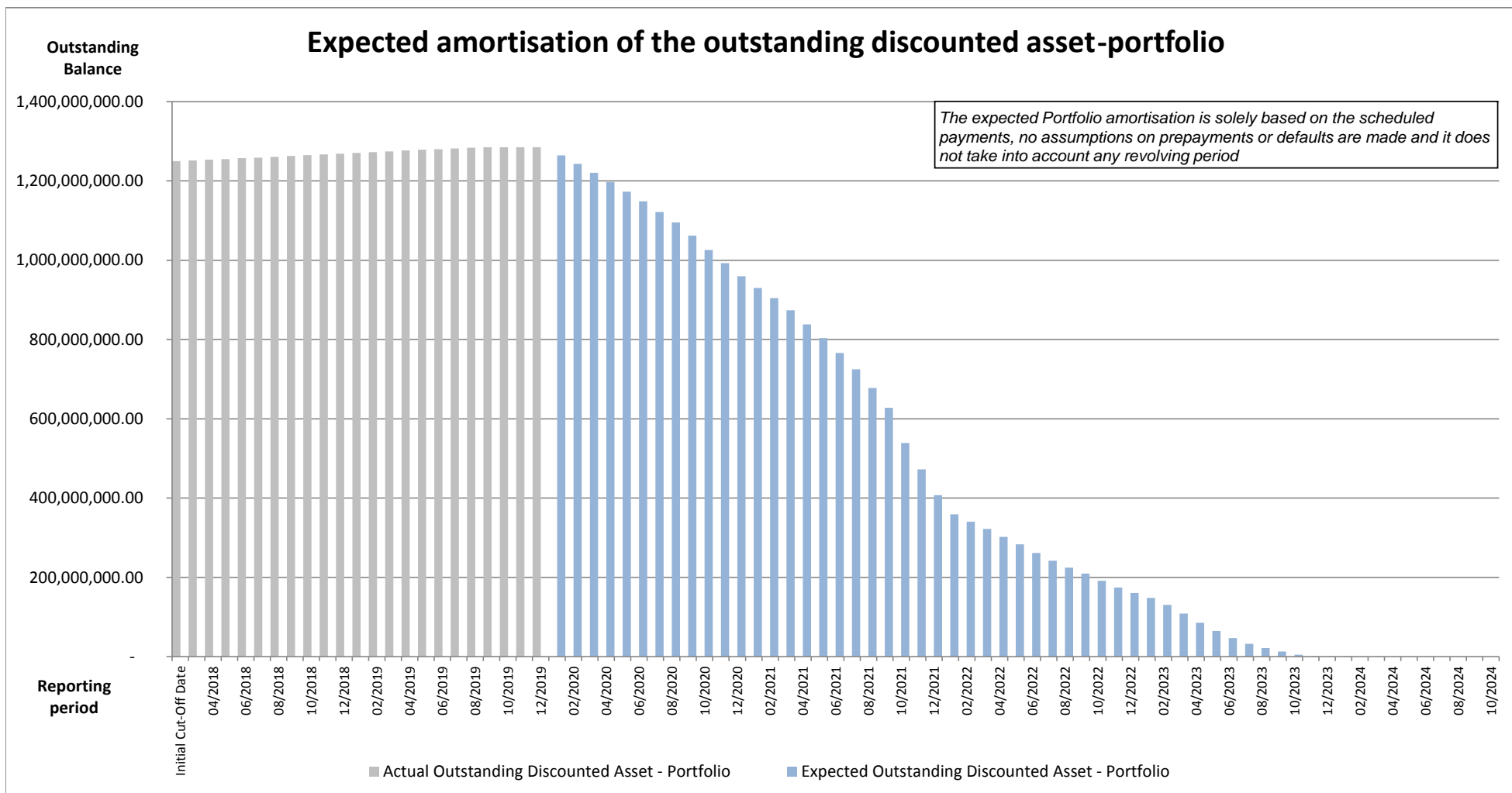
**Amortisation profile II**

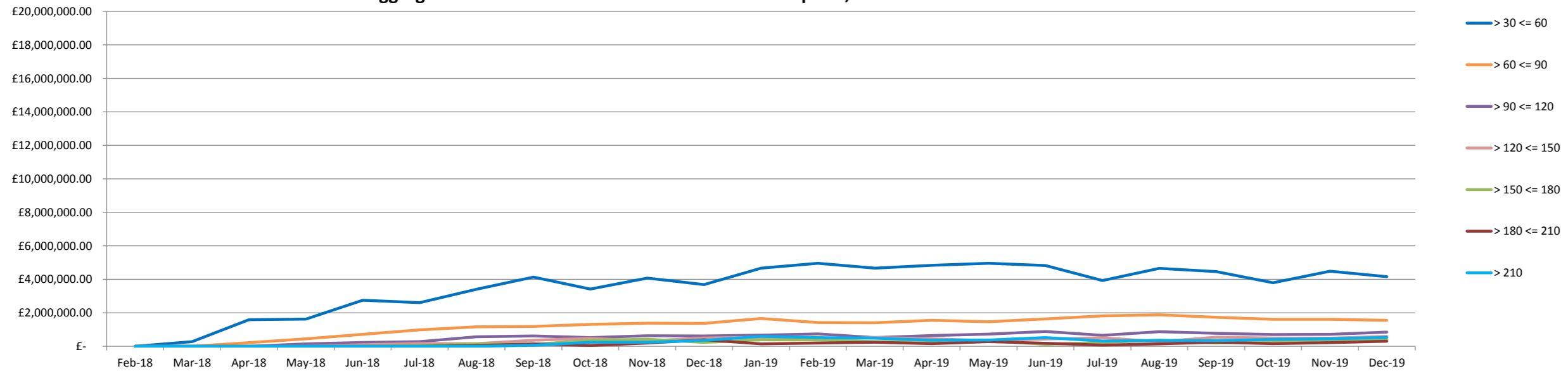

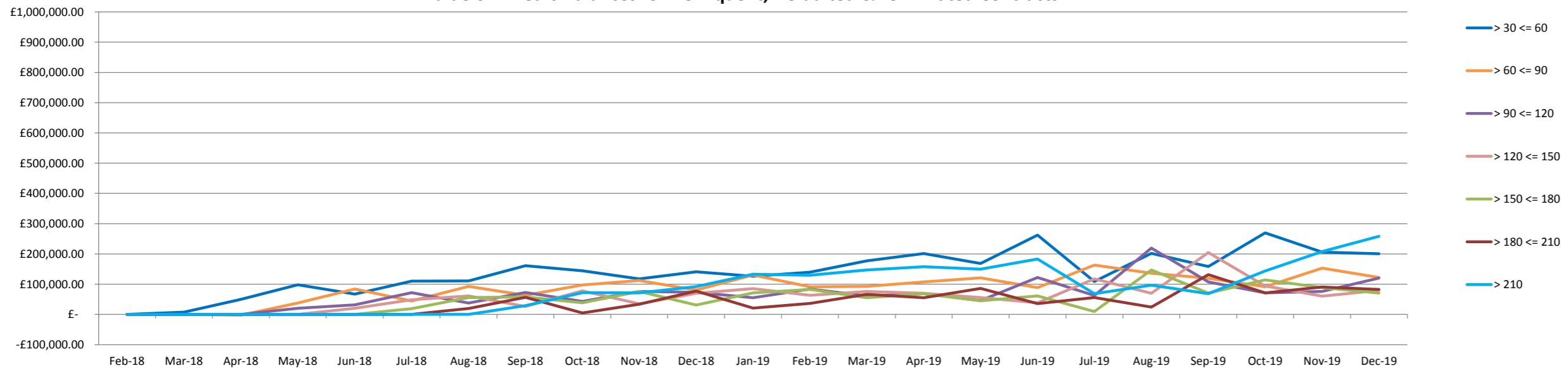
